

GOLF COURSE COMMITTEE MEETING

The January 26, 1974 Meeting of the Golf Course Committee was held at 9:30 a.m. Saturday at the Town Hall.

Members present: Don Brooks, David Canfield, Fred Orrico, Vincent Paccadolmi, Ray Phelan and Gino Torcellini

Chairman Don Brooks began the Meeting with a brief review of his meeting with Larry Fischer, in the company of Vincent Paccadolmi and Ray Phelan, at Mr. Brook's home on Wednesday night. They discussed slow progress at the Site, equipment problems and gasoline shortages, and the possible purchase of putting a backhoe on the front loader and having repair made for \$1868.

Rodney Anderson and two other fellows owe the Golf Course some work--could they possibly get the Town backhoe and work on the brook and make some drainage ditches some Saturday? Fred Orrico will talk to Mr. Anderson.

Joe Knapp was contacted and he does have ample wood chips; could we get some from his dumping area? could arrangements be made for him to dump some at the Town Dump and we get them there? It is too far for him to take them to the Site.

PRO hiring was discussed--for \$4000 he would 1) run pro shop, 2) be responsible for starting and taking of tickets (but we would pay the employee), 3) he would buy his own carts and lease them, 4) consignment on pro shop, 5) teach lessons, 6) be responsible for income and bookkeeping--April till Thanksgiving
