

COURSE REGULATIONS

All players must purchase their ticket in the golf shop before teeing off. Any Player found on the course without this proof of payment will be expelled and face suspension.

Players who are abusive and refuse to follow course procedures will be asked to leave and face suspension.

No alcoholic beverages are allowed on the course except that which is dispensed in the concession and according to the ordinance sign posted on the first tee.

Cans, coolers and bottles are not allowed on the course. Water is provided on the course.

Players must wear proper attire and golf shoes or sneakers. Metal spiked footwear is prohibited. Boots and work shoes are not allowed. Short shorts, tennis, athletic shorts, tank tops, cut offs, or bathing suits are not permitted.

Riding cart regulations will be strictly enforced with suspension levied for serious infractions:

- A) Only two riders per cart
- B) Only two bags per cart
- C) No one under the age of 16 is allowed to operate a riding cart
- D) Juniors (16 & 17) must have a valid drivers license, and be accompanied by an adult
- E) Carts are to be confined to cart paths and roughs unless otherwise posted
- F) Damage to riding carts will be appraised by an authorized dealer and charged to the offending operator

All business operations have opening and closing hours—even though golf operations are longer than most, closing hours have to be enforced because of insurance and employee regulations. Carts will be leased up until the hours posted and not beyond. These hours will be adjusted according to the time of year.

Play one ball. Practicing, playing more than one ball, should be done on the golf range, not on the course.

Players must produce dated receipt when requested by rangers, and accept rule warnings without challenge or disruption.

No one is allowed on the course except registered players and employees.

Players must have their own bag and clubs. Rental sets are available.

Players asked to leave the course because of a rule infraction will not receive a refund (except on riding carts not beginning the last nine holes).

Rainchecks will be issued only if the course is closed and the player has not completed nine holes. Late play rainchecks will not be issued.

The golf shop personnel or starter control the play off the 1st and 10th tee. The order and pairing of players will be governed by them.

The course must be played in the proper sequence as designated on the score card. Crisscrossing is not permitted.

A round of golf starts after the first tee shot unless negated by weather exceptions. The maximum holes played in a round being 18.

Golf Cart fees must be paid in the golf shop before teeing off. If a player desires to continue after paying a nine hole rate, the additional fee must be paid before teeing off on the final nine holes.

Resident rates and privileges are available only to those players holding a resident photo permit.

Junior golf is encouraged. Please check with the staff regarding Junior regulations.

As we all know any public facility must have order and control so as to offer equal enjoyment and recreation for all making use of it. The listed rules and regulations are intended for the sole purpose of maintaining a course that offers a pleasant diversion for those playing golf. A serious infraction or persistent disruption of these rules will result in suspension of all course privileges according to the town ordinance.
